

**ORDINANCE 2000-25**

**AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF TOOELE COUNTY; REZONING CERTAIN PROPERTY IN ERDA FROM A-20 (AGRICULTURE 20-ACRE MINIMUM) TO RR-5 (RURAL RESIDENTIAL 5-ACRE MINIMUM)**

**THE COUNTY LEGISLATIVE BODY OF THE COUNTY OF TOOELE ORDAINS  
AS FOLLOWS:**

**SECTION I - AMENDMENT:** The official zoning map of Tooele County is hereby amended by changing the zoning designation of the following described property in Erda from A-20 (Agriculture 20-Acre Minimum) to RR-5 (Rural Residential 5-Acre Minimum):


Beginning at point South 89°59'09" West 619.36 feet along the section line and South 33.15 feet from the Northeast corner of Section 35, Township 2 South, Range 4 West, Salt Lake Base and Meridian; thence South 16°39'34" East 40.36 feet; thence South 06°16'58" East 584.41 feet; thence South 06°42'19" East 282.33 feet; thence North 88°28'17" East 39.76 feet; thence South 05°50'36" East 390.50 feet; thence South 05°11'57" East 231.00 feet; thence South 89°41'36" West 1040.00 feet; thence North 00°32'46" West 231.00 feet; thence South 89°53'46" East 144.70 feet; thence North 00°04'44" East 511.68 feet; thence South 89°58'57" East 459.49 feet; thence North 00°02'30" East 779.37 feet; thence South 89°38'53" East 206.24 feet, returning to the point of beginning.

**SECTION II - REPEALER.** Ordinances in conflict herewith are hereby repealed to the extent of such conflict.




IN WITNESS WHEREOF, the legislative body of Tooele County passed, approved and enacted this ordinance this 19<sup>th</sup> day of September 2000.
