

ORDINANCE 2000-36

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF TOOELE COUNTY; REZONING CERTAIN PROPERTY SOUTHWEST OF THE ERDA AIRPORT FROM A-20 (AGRICULTURE 20-ACRE MINIMUM) TO RR-5 (RURAL RESIDENTIAL 5-ACRE MINIMUM)

THE COUNTY LEGISLATIVE BODY OF THE COUNTY OF TOOELE ORDAINS

AS FOLLOWS:

SECTION I - AMENDMENT: The official zoning map of Tooele County is hereby amended by changing the zoning designation of the following described property in Southwest of the Erda Airport from A-20 (Agriculture 20-Acre Minimum) to RR-5 (Rural Residential 5-Acre Minimum):

Beginning at a point which is the southeast corner of Section 36, Township 2 South, Range 5 West, Salt Lake Base and Meridian, and running thence along south line of said Section 36 South 89°41'30" West 1,650.00 feet; thence North 0°13'05" West 2,607.00 feet to the south line of Erda Way; thence North 89°41'30" East 7.35 feet along the south line of said Erda Way; thence South 0°13'05" east 30.00 feet; then North 89°41'30" East 60.00 feet; thence North 0°13'05" West 30.00 feet to the south line of Erda Way; thence North 89°41'30" East 1,317.65 feet along the south line of said Erda Way; thence South 0°13'05" East 986.00 feet; thence North 89°41'30" East 265.00 feet to the section line of Section 36; thence along said section line South 0°13'05" East 1,621.00 feet to the point of beginning.


SECTION II - REPEALER. Ordinances in conflict herewith are hereby repealed to the extent of such conflict.




