

ORDINANCE 2002-03

**AN ORDINANCE AMENDING TOOELE COUNTY CODE
TITLE 1, CHAPTER 3, SECTION 7, RE-ESTABLISHING
FEES FOR SERVICES PROVIDED BY COUNTY OFFICES**

THE COUNTY LEGISLATIVE BODY OF THE COUNTY OF TOOELE ORDAINS

AS FOLLOWS:

SECTION I - PURPOSE. This ordinance is for the purpose of complying with Utah Code Annotated 17-53-211 which requires the county legislative body to adopt an ordinance establishing fees for services provided by each county officer except fees for the recorder, sheriff and constables, and fees established by statute.

SECTION II - AMENDMENT. Title 1, Chapter 3, Section 7 of the Tooele County Code is hereby amended to read:

1-3-7. Officials' fees.

(1) Pursuant to Utah Code Annotated 17-53-211, the following fees are hereby established for services provided by the corresponding county officer:

SECTION III - REPEALER. Ordinances and resolutions in conflict herewith are hereby repealed to the extent of such conflict.






