

ORDINANCE NO. 2002-23

AN ORDINANCE OF TOOELE COUNTY, UTAH, CREATING AND ESTABLISHING THE REDEVELOPMENT AGENCY OF TOOELE COUNTY; DESIGNATING THE COUNTY COMMISSION TO BE THE GOVERNING BODY OF THE RDA PURSUANT; GRANTING THE AGENCY AUTHORITY AS PROVIDED BY STATE LAW; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Tooele County Commission has determined that it is in the best interests of Tooele County to consider the creation and adoption of one or more redevelopment or economic development plans and to consider taking action to redevelop or develop certain areas of the County; and

WHEREAS, the Commission deems it desirable that certain economic development or redevelopment activities in the County be carried out pursuant to the provisions of the Utah Redevelopment Agencies Act.

NOW, THEREFORE, BE IT ORDAINED by the legislative body of Tooele County, Utah:

SECTION I. SECTION ENACTED. Section 11-10-1 of the Tooele County Code is enacted to read:

11-10-1. Agency established.

Pursuant to Utah Code Ann. Subsection 17B-4-201(1) of the Utah Redevelopment Agencies Act, Tooele County hereby creates and establishes the Redevelopment Agency of Tooele County and directs that the requirements of Subsections 17B-4-201(2) and (3) be complied with to finalize the creation and establishment of the Agency pursuant to law.

SECTION II. SECTION ENACTED. Section 11-10-2 of the Tooele County Code is enacted to read:

11-10-2. Governing body.

Pursuant to Utah Code Ann. Section 17B-4-203, the governing body of the Redevelopment Agency of Tooele County shall be a board consisting of the current members of the legislative body that created the Agency, namely, the members of the County Commission of Tooele County.

SECTION III. SECTION ENACTED. Section 11-10-3 of the Tooele County Code is enacted to read:

11-10-3. Powers.

The Redevelopment Agency of Tooele County is authorized to enter into agreements generally in connection with redevelopment, economic development and education housing development matters and shall have the power to transact the business of a redevelopment agency and also to exercise all the powers, rights, duties and privileges set forth and provided for in the Utah Redevelopment Agencies Act, Utah Code Annotated 1953, 17B-4-101, et seq., and any successor or replacement law or act, and as the same may from time to time be amended. All other provisions of applicable Utah State law, as the same may from time to time be amended, are hereby adopted by this reference as if fully set forth herein.

SECTION IV - EFFECTIVE DATE. This ordinance shall become effective 15 days after its passage provided it has been published, or at such publication date, if more than 15 days after passage.






