

ORDINANCE NO. 2004-02

**AN ORDINANCE ESTABLISHING TOOELE COUNTY ELECTION
PRECINCTS AND REAPPORTIONING TOOELE COUNTY SCHOOL
BOARD ELECTION DISTRICT BOUNDARIES**

THE BOARD OF COUNTY COMMISSIONERS OF TOOELE COUNTY ORDAINS

AS FOLLOWS:

SECTION I - PURPOSE. This ordinance is for the purpose of amending Tooele County election precincts and for reapportioning the Tooele County School Board election districts pursuant to Section 20A-14-201 et seq. UCA, as amended.

SECTION II - REPEAL OF CONFLICTING ORDINANCES. All Tooele County ordinances or parts of ordinances in conflict with any provision of this ordinance are hereby repealed.

**SECTION III - ESTABLISHMENT OF NEW TOOELE COUNTY ELECTION
PRECINCTS.** There are hereby established thirty-eight (38) election precincts within Tooele County as described by the maps attached hereto, which are by this reference, made a part hereof. The abbreviated designations for each precinct on the attached maps shall be interpreted according to the following legend: T1 through T19 refers to Tooele precincts #1 through #19; G1 through G5 refers to Grantsville precincts #1 through #5; LP refers to Lake Point; SP1 through SP 3 refers to Stansbury Park precincts #1 through #3; ER refers to Erda; L1 refers to Lincoln; ST refers to Stockton; OP refers to Ophir; RV refers to Rush Valley; VE refers to Vernon; TE refers to Terra; DU refers to Dugway; IB refers to Ibapah; and WE refers to Wendover.

**SECTION IV - LOCAL SCHOOL BOARD ELECTION DISTRICTS
REAPPORTIONED.** The Tooele County School Board election districts are hereby reapportioned in conformity with the election precincts established in Section III as follows:

1. **Tooele County School Board District Number 1** shall consist of and include the following Tooele County election precincts: Tooele #6 (T6), Tooele #15 (T15), Tooele #16 (T16), Tooele #17 (T17), and Tooele #19 (T19).

2. **Tooele County School Board District Number 2** shall consist of and include the following Tooele County election precincts: Tooele #1 (T1), Tooele #2 (T2), Tooele #3 (T3), Tooele #4 (T4), Tooele #18 (T18).

3. **Tooele County School Board District Number 3** shall consist of and include the following Tooele County election precincts: Tooele #5 (T5), Tooele #8 (T8), Tooele #9 (T9), Tooele #11 (T11), and Lincoln (L).

4. **Tooele County School Board District Number 4** shall consist of and include the following Tooele County election precincts: Tooele #7 (T7), Tooele #10 (T10), Tooele #12 (T12), Tooele #13 (T13), and Tooele #14 (T14).

5. **Tooele County School Board District Number 5** shall consist of and include the following Tooele County election precincts: Grantsville #1 (G1), Grantsville #2 (G2), Grantsville #3 (G3), Grantsville #4 (G4), and Grantsville #5 (G5).

6. **Tooele County School Board District Number 6** shall consist of and include the following Tooele County election precincts: Stansbury Park #1 (SP1), Stansbury Park #2 (SP2), Stansbury Park#3 (SP3), Erda (E), and Lake Point (LP).

7. **Tooele County School Board District Number 7** shall consist of and include the following Tooele County election precincts: Stockton (ST), Ophir (OP), Rush Valley (RV), Vernon (VE), Terra (TE), Dugway (DU), Ibapah (IB), and Wendover (WE).


SECTION V - MAP INTERPRETATIONS. It is intended that election districts be divided by roadways, where possible. If a map shows a boundary close to but not exactly on a road, the road shall nevertheless be considered the dividing line.


SECTION VI - EFFECTIVE DATE. In the opinion of the Board of County Commissioners of Tooele County, it is necessary for the immediate preservation of the peace, health and safety of the county and the inhabitants thereof that this ordinance shall take effect immediately upon publication in one issue of a newspaper having general circulation within the county.


