**ORDINANCE 2004-19**

**AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF TOOELE COUNTY; REZONING 6.6 ACRES IN SECTION 34, T2S, R5W SLB&M IN ERDA FROM A-20 TO RR-1**

**THE COUNTY LEGISLATIVE BODY OF THE COUNTY OF TOOELE ORDAINS**

**AS FOLLOWS:**

**SECTION I - AMENDMENT.** Having conducted a public hearing thereon and finding good cause therefor, and that the rezone request complies with the general plan, the official zoning map of Tooele County is hereby amended at the request of Kathleen Bailey by changing the zoning designation of Section 34 of Township 2 South, Range 5 West, Salt Lake Base and Meridian, from A-20 (Agricultural District - 20) to RR-1 (Rural Residential District - 1 acre minimum). This 200 foot wide parcel formerly belonged to Union Pacific Railroad.

A map showing the area of the rezone is attached hereto and by this reference made a part hereof.

**SECTION II - REPEALER.** Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION III - EFFECTIVE DATE.** This ordinance shall take effect fifteen (15) days after its passage, provided the same has been published, with the name of the members voting for and against the same, for at least one publication in one issue of a newspaper published in and having general circulation in Tooele County.




