

**ORDINANCE 2006-05**

**AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF TOOELE COUNTY; REZONING APPROXIMATELY 213 ACRES OF PROPERTY OWNED BY DAVE DOMINGUEZ LOCATED BETWEEN TOOELE ARMY DEPOT AND SOUTH MOUNTAIN FROM MU-40 TO MG-EX**

**THE COUNTY LEGISLATIVE BODY OF THE COUNTY OF TOOELE ORDAINS**

**AS FOLLOWS:**

**SECTION I - AMENDMENT:** Pursuant to Utah Code Sections 17-27a-502 and 503, the Tooele County Planning Commission conducted a public hearing on Dave Dominguez's application for rezone and recommended the amendment to the official zoning map of Tooele County.

Notice having been provided as required by Subsection 17-27a-205(1)(b) and having held a public meeting, the official zoning map of Tooele County is hereby amended by changing the zoning designation of property owned by Dave Dominguez located between Tooele Army Depot and South Mountain, being Parcels 06-016-0-0002 and 06-015-0-0003, in Sections 8 and 9, Township 4 South, Range 5 West, Salt Lake Base and Meridian, comprising approximately 213 acres, from MU-40 (Multiple-Use, 40-Acre Minimum Lot Size) to MG-EX (Mining, Quarry, Sand and Gravel Excavation).

**SECTION II - REPEALER.** Ordinances in conflict herewith are hereby repealed to the extent of such conflict.






