

ORDINANCE 2008-13

AN ORDINANCE AMENDING SECTION 1-4-2 OF THE TOOELE COUNTY CODE, CONSOLIDATING THE WENDOVER AND TOOELE VALLEY JUSTICE COURT PRECINCTS INTO A SINGLE PRECINCT KNOWN AS THE TOOELE COUNTY JUSTICE COURT

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF TOOELE COUNTY, UTAH AS FOLLOWS:

SECTION I - PURPOSE. This ordinance is for the purpose of consolidating the Wendover and Tooele Valley Justice Court precincts into a single precinct known as the Tooele County Justice Court.

SECTION II - SECTION AMENDED. Section 1-4-2, Justice Court Precincts Boundaries - Legal Description, of Title 1, General Provisions, of the Tooele County Code is hereby amended to read as follows:

1-4-2. Justice court precinct boundary - Legal description.

There is hereby established a single justice court precinct in Tooele County known as the Tooele County Justice Court. The boundaries of which include all of Tooele County.


SECTION III - REPEALER. Ordinances and resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION IV - EFFECTIVE DATE. This ordinance shall become effective 15 days after its passage provided it has been published, or at such publication date if more than 15 days after passage.



1-4-2. Justice court precincts boundaries - Legal descriptions.

There are ~~is~~ hereby established the following ~~Tooele County Justice Court Precincts~~: a single justice court precinct in Tooele County known as the Tooele County Justice Court. The boundaries of which include all of Tooele County.

~~— (1) Tooele Valley Justice Court Precinct. Beginning at a point where Tooele, Box Elder, Weber and Davis Counties meet; thence running Southerly along the East boundary line of Tooele County to the South boundary line of Tooele County; thence West along the South boundary line of Tooele County to the Southwest corner of Township 10 South, Range 9 West, Salt Lake Base and Meridian; running thence due North to the North boundary line of Tooele County; thence Easterly along the North boundary line of Tooele County to the point of beginning and including therein each City and Town located within such boundaries, including Tooele City, Utah.~~

~~— (2) Wendover Justice Court Precinct. Beginning at the Southwest corner of Township 10 South, Range 9 West, Salt Lake Base and Meridian; thence due North to the Northern boundary of Tooele County; thence West along the Northern boundary to the Northwest corner of Tooele County; thence South along the Utah-Nevada State Line to the Southwest corner of Tooele County; thence East along the Southern boundary of Tooele County to the point of beginning and including therein each City and Town located within such boundaries, including Wendover City, Utah.
