

**ORDINANCE 2011-15**

**AN ORDINANCE AMENDING SUBSECTION 1-6-3(7) OF THE TOOELE COUNTY CODE, ESTABLISHING FEES FOR BULK DATA AND BULK DOCUMENT DOWNLOADS FROM THE RECORDER'S OFFICE**

**NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF TOOELE COUNTY, UTAH AS FOLLOWS:**

**SECTION I - PURPOSE.** This ordinance is for the purpose of complying with Utah Code Annotated 17-53-211 which requires the county legislative body to adopt an ordinance establishing fees for services provided by each county officer, except fees for the recorder, sheriff, county constables, and fees established by statute. This ordinance amends the fees charged by the Recorder's Office by establishing fees for bulk data and bulk document downloads.

**SECTION II - SUBSECTION AMENDED.** Subsection 1-6-3(7), Recorder, of Section 1-6-3, Officials' Fees, of the Tooele County Code is hereby amended to read as attached hereto, which attachment is, by this reference, made a part hereof.

**SECTION III - REPEALER.** Ordinances in conflict herewith are hereby repealed to the extent of such conflict.


