

ORDINANCE 2006-29

AN ORDINANCE AMENDING SECTION 1-6-3 OF THE TOOELE COUNTY CODE, AMENDING THE FEES CHARGED BY THE CLERK'S OFFICE AND BY THE DESERET PEAK COMPLEX, ADDING FEES PERTAINING TO THE NEW PITCH AND PUTT GOLF COURSE

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF TOOELE COUNTY, UTAH AS FOLLOWS:

SECTION I - PURPOSE. This ordinance is for the purpose of complying with Utah Code Annotated 17-53-211 which requires the county legislative body to adopt an ordinance establishing fees for services provided by each county officer except fees for the recorder, sheriff and constables, and fees established by statute.

SECTION II - SECTION AMENDED. Title 1, Chapter 6, Section 3 of the Tooele County Code is hereby amended to read as attached hereto, which attachment is, by this reference, made a part hereof.


SECTION III - REPEALER. Ordinances and resolutions in conflict herewith are hereby repealed to the extent of such conflict.

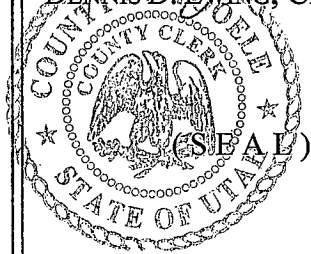


