

ORDINANCE 2007-29

AN ORDINANCE AMENDING THE TOOEELE VALLEY ROAD PLAN, WHICH IS PART OF THE TOOEELE COUNTY MASTER ROAD PLAN, ELIMINATING A SECTION OF DROUBAY ROAD IN THE LAKE POINT AREA AS A PROPOSED MAJOR COLLECTOR

WHEREAS, the purpose of the Tooele Valley Road Plan is to identify current public roads and to anticipate and make preparations for future public roads in the Tooele Valley; and

WHEREAS, the Tooele Valley Road Plan is a part of the Tooele County Master Road Plan; and

WHEREAS, eliminating a section of a proposed major collector, involving Droubay Road in the Lake Point area, from the Tooele Valley Road Plan is advised because a future connection of Droubay Road with SR-36 is unset; and

WHEREAS, development of the section of Droubay Road from Center Street at approximately 6800 North through Lake Point to a future connection with SR-36 is problematic due to building around multiple existing residential developments; and

WHEREAS, elimination of this proposed extension will not pose a future hardship with connection to SR-36 due to the proximity with the current signalized intersection of Center Street and SR-36.

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF TOOEELE COUNTY, UTAH AS FOLLOWS:

SECTION I - AMENDMENT. Pursuant to Utah Code Sections 17-27a-204 and 205, the Tooele County Planning Commission conducted a public hearing on the proposal to amend the Tooele Valley Road Plan, which is a part of the Tooele County Master Road Plan, and recommends the amendment.

Notice having been provided as required by Subsection 17-27a-205(1)(b) and having held a public meeting, the Tooele County Master Road Plan is hereby amended by eliminating a section of a proposed major collector, involving Droubay Road in the Lake Point area, from the Tooele Valley Road Plan. A map of the amendment is attached hereto and by this reference made a part hereof.


SECTION II - REPEALER. Ordinances and resolutions in conflict herewith are hereby repealed to the extent of such conflict.

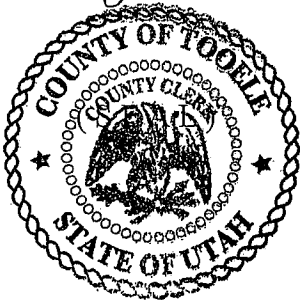
