

RESOLUTION 2014-20

A RESOLUTION ESTABLISHING THE SALARIES OF THE TOOELE COUNTY OFFICERS FOR THE 2015 FISCAL YEAR

WHEREAS, Utah Code Annotated, Section 17-36-15 requires the Tooele County Commission to adopt by resolution its 2015 fiscal year budget, including the salaries of the Tooele County officers, on or before the last day of the fiscal period which is December 31, 2014, in Tooele County; and

WHEREAS, the tentative budget and all supportive schedules and data were available for public inspection, including the salaries of the Tooele County officers, during business hours at the offices of the county clerk or auditor for at least ten (10) days prior to the public hearing on the adoption of the final budget as required by Utah Code 17-36-11; and

WHEREAS, Utah Code Annotated, Section 17-16-14, requires the Tooele County Commission to fix the salaries of the Tooele County officers for the 2015 fiscal year; and

WHEREAS, pursuant to Utah Code Annotated, Section 17-16-14, a public hearing on the proposed salaries of the county officers for the 2015 fiscal year was regularly noticed up and conducted by the Tooele County Commission on December 2, 2014.





All County officers listed above shall receive, in addition to the above-mentioned salaries, the same retirement and other fringe benefits afforded all other Tooele County employees, including family health/dental coverage at the same cost as regular county employees.

Tooele County constables shall not receive any compensation, salary, insurance, or other employee fringe benefits afforded other county employees. The constables' reimbursement shall be derived exclusively from statutory fees charged for services provided.
