Kerry showed the location on map, and stated that the road is maintained by traffic only. It is an undedicated road, on Kennecott Property. Concerns are trespassing, littering, shooting. If County vacates the road, Kennecott will fence it.

Brian Davis from Kennecott spoke about need for something to be done for public safety.

The fence (barbed wire along part and something more substantial where it is needed) will extend from Bob Salt's property to RR along road. Also a better 'no trespassing' sign will be installed. Radell Donnell asked about a fence on southern portion (east/west road TC#03602) where there is a shooting problem also. Brian said he would recommend vacation. Kerry said that staff had not looked into this road, the request came through the County Attorney's Office that only a portion of TC#03601 be vacated as indicated. If the planning commission requested it, the staff will pursue action.
